

# LEBANON, OREGON PUBLIC SLEEPING GUIDANCE AND RESOURCES

The City of Lebanon recognizes the right of all persons to sleep or rest with reasonable protection from the elements.

## DAYTIME

Public parks are open from 7:00 a.m. to 10 p.m., and are accessible to all members of the public.

All park users must abide by park rules, including no smoking, vaping or alcohol in any City park.

All members of the public may lay down, sit, sleep or rest in public parks during park hours.

## OVERNIGHT

Overnight sleeping areas are available (see map).

Overnight sleeping areas are available for use from 6:00 p.m. until 7:00 a.m.

Individuals may erect temporary structures in overnight sleeping areas to assist with protection from the elements.

All temporary structures and personal property must be removed by 7:00 a.m.

### **Camping in Lebanon is prohibited except in Designated Campsites (LMC 12.14.020).**

- Camping means the establishment of temporary accommodation and/or structures for overnight stays.
- Camping is prohibited on all Lebanon Public Spaces, including streets, parks and public recreation areas.
- A campsite is any place where one or more people establish sleeping accommodations with or without structures and is not within an Overnight Sleeping Area or City Park when those areas are open for public use.
- All unauthorized campsites may be removed by the City with or without notice.

# LEBANON, OREGON PUBLIC SLEEPING GUIDANCE AND RESOURCES


**Lebanon regulates its public space for the benefit of ALL of its citizens.**

No person may obstruct or impede any street, sidewalk, public right-of-way, Recreation Area or other public property by sitting, lying or sleeping, or by storing or placing personal property on such property (LMC 12.14.040).

## OVERNIGHT SLEEPING AREAS:

- **Lebanon Justice Center** / 40 N. 2nd Street (the lawn in front of the Justice Center on the Second Street-side).
- **Oak Street** / 305 W. Oak Street (the bark area between the sidewalk and the fence along Oak Street by the Maintenance Shops).

- **No fires allowed in City parks or overnight sleeping areas.**
- **A person may not accumulate, discard, or leave behind garbage, debris, unsanitary or hazardous materials, or other items of no apparent utility on any City property.**
- **No temporary structure shall be tied to, secured to, staked or anchored, or attached in any way to a permanent structure.**
